Instead, it has been agreed to call an extraordinary meeting to deal with those applications because of the significant public interest in them and to allow more time for discussion. Police Matters

The police were not present. The clerk reported that a police officer had called at the parish office recently but there was nothing specific to report. It was noted that there has recently been some vandalism to cars.

Planning Matters

The proposed extraordinary meeting was welcomed. Concern was expressed about the number of planning applications which seem to come through at holiday periods. The parish council needs to have a plan in place to deal with this situation.

One Way System

Residents had recently experienced a near head on collision with a car turning the wrong way out of the club car park. They have emailed the club to ask if they would consider installing signage at the exit from their car park. The parish council agreed to contact WCC Highways to ask for better signage.

1 Lease

The lease has now been completed.

2 Update from Cllr Lockley

HEI's proposal to install solar panels on the library roof using grant funding was considered. Concerns were raised about installing panels on a listed building in a conservation area, possible damage to the roof and the cost benefits. It was **RESOLVED** not to support the proposal.

6 Proposed Solar Farm, Fosse Way

Some councillors, but not all, had attended the pre-application consultation. There were some concerns about access off the busy Fosse Way during the construction period and also the visual impact on the view from Ufton Hill. The council had no comments to make to the developer at this stage but the clerk will ask for the results of the public consultation.

7 Solar Farm, Long Itchington/Bascote – planning application ref 15/01740/FUL

It was agreed not to express any formal view on this application which is several miles from Harbury.

9 Harbury Cement Works Development

The clerk has requested an update but no reply has been received yet.

10 Neighbourhood Development Plan

The grant award of £7000 has come through. The draft document was discussed this week and is now being revised. The consultant needs to address the whole PC as there are some decisions to be made.

Cllr Thornley reported that the Three Arch Bridge is to be closed for 3 months. Residents are concerned about this as an alternative access is being proposed from Ufton Fields. It was agreed to include this on the agenda for 4 August 2015.

1 Play Areas

The wet pour resurfacing is on order. No date for installation has been received yet.

Repairs to the skate park are still outstanding. The quarterly inspector will do this next time he visits.

The white lines are breaking up again which is very disappointing. Perhaps Cllr Lockley will be able to follow this up with Murphy's. The lamp posts are still leaning. The clerk has placed the order with WCC and will follow it up.

The clerk is still waiting to hear from the tree surgeon.

The clerk has already contacted those groups who are known to have equipment stored in the chapel and they are all willing to help. It was suggested that a Saturday in September would be a good time to do this. Cllr Lockley is to be asked to organise a date so a skip can be ordered.

Hosepipes

A tenant has enquired about the use of hosepipes to fill watering cans. There is nothing in the tenancy agreement to prohibit this practice. The council was not aware of any other requirement. The clerk will advise the tenant accordingly.

Unoccupied Plots

There are a couple of unoccupied plots next to the field boundary and the weeds are causing a problem for the farmer. It was agreed to defer the discussion about how to manage this until Cllr Ekins was present.
