17/89 Casual Vacancy - Co-option

1 Introduction of candidates

Mr Andrew Rutherford was the only candidate. His application letter had been circulated to members prior to the meeting. There were no questions.

It was **RESOLVED** to co-opt Andrew Rutherford to the vacancy created by the resignation of Cllr Knowles. Cllr Rutherford signed his declaration of acceptance of office which was counter signed by the clerk.

Road Closure, Bush Heath Lane

Has there been any official notice for the road closure? It was thought it was to do with the gas supply. It was asserted that DWH lorries are knocking the diversion signs over.

New Houses, Dovehouse Lane

The new houses have a bright orange roof which is not in keeping with the surrounding buildings. Mrs Ridgley is going to write to SDC about this.

Transfer of Public Open Space, Bush Heath Lane

It was noted that David Wilson Homes is offering to transfer ownership of the public open space to the parish council. There was concern about this on grounds of cost to the parish. Also, the tree report does not appear to have been acted upon. Will the swale also be included?

Damage to kerbs, Bush Heath Lane

Concerns about damage to kerbs by DWH lorries had been raised at last month's meeting. The clerk has been in touch with DWH who photographed the surrounding roads and verges before they began work and have given their assurance to reinstate when the building work has been completed.

9 SDC & WCC

SDC

- Cllr Harris is going to talk to the Streetscene officer at SDC about the weed spraying of the paths which was raised last month.
- The GLH planning application for treatment of the B4100 under the Sec106 agreement was granted permission last week.

WCC

- The annual meeting has taken place. The council now has 35% newly elected councillors.
- If the PC can identify any small highways works, please let Cllr Stevens know as there is £32K budget for this.
- Cllr Stevens is meeting the county highways officer soon so please let him know of any major road issues.
- Cllr Ekins raised the problem of numerous lorries from the Southam developments using the B4451 and not realising that there is a weak bridge at Deppers Bridge which they are then forced to cross because there is nowhere for them to turn round. Please could some improved signage be considered? Cllr Gibb added that this certainly needs consideration before work begins on HS2.
- Cllr Stevens believes that the Harbury Lane/Fosse Way junction will be improved within the next 4 years. He will be following this up.

1 Play Areas & Playing Fields

i Climbing Wall

The clerk is waiting for a third quote. The prices she has received from Wicksteed also require clarification.

ii Repairs

The skate park repairs have now been completed. The repairs in the play area are ongoing.

iii New path

Two of the three benches have now been installed. A complaint has been received about youths gathering in this area which is to be monitored. The clerk will obtain a further quote from the council's contractor for the supply only of materials to extend the path. The resident who offered his labour free of charge is to be asked if he is still willing to proceed on this basis. Cllr Lockley has sent some text to Mr Marshall-Hardy for the information board and leaflets. The clerk will follow this up.

A complaint has been received about the surface of the new path. It was agreed to look into the costs of upgrading the surface. Perhaps a grant could be obtained from WCC Highways?

5 Public Open Space, Oakfields

David Wilson Homes has offered to transfer ownership of the on-site open space in accordance with their obligations under the Sec 106 agreement. It was **RESOLVED** not to accept the transfer. This means that the public open space will be managed by the management company for the development instead of being maintained by the parish council.
