# Planning Application – Tree at 1, The Pound

Mrs Ridgley raised concerns about the crown lifting which she doubted was necessary. This is an iconic tree in the village and lots of people will be upset if it is damaged. She has been advised by a tree surgeon that taking out a branch could open up the tree to infection. She asked for an arboricultural consultant to inspect the tree and hoped that the parish council would pursue this with SDC.
